Caritas Zonta Club of Hong Kong Nursery School Information on Admission in the 2024/25 School Year

1. Application Procedures

- 1.1 The 11 preschools and kindergartens under Caritas Hong Kong accept public applications for admission. For the application procedures, please visit our website: <u>https://zcns.caritas.org.hk/index.aspx</u> for details.
- 1.2 In October to March, the school will notify parents who have submitted the application form individually by letter, we will arrange a date and time to meet our new students and their parents. Appointments are generally arranged from November to March;
- 1.3 The school will send the admission result of the child by letter within three weeks after the meeting with the parents by post.
- 1.4 The parents of students who have been admitted must pay a registration fee within the specified date; the waiting students will be included in the waiting list; after the unified registration day, if the school still has places, the school will accept those waiting students and notify parents to arrange for registration procedures.
- 1.5 The school will hold a parent meeting for new students in May every year to explain the admission arrangement; if there is a place in the future, the school will arrange the registration procedures for other waiting students;
- 1.6 According to the administrative guidelines of the organization, all application forms for students who have not been admitted will be stored for one year and then be destroyed. During this period, if parents have any enquiries, they can contact the school directly.

2. Interview Arrangement

- 2.1 Group interviews/ individual interviews will be arranged. We will observe the child's behavior and interview with the parent.
- 2.2 One of the parents is required to accompany their child for the interview.
- 2.3 Interview will be conducted in Cantonese. Please contact us at 2675 0099 if interpretation / translation service if required.

3. Admission Criteria and Factors for Consideration

- 3.1 The child should be at least 2 years and 8 months old (For K1 class) and at least 2 years old (For N1 class) when she/he is admitted in September 2024.
- 3.2 Interview performance of the child.
- 3.3 The alignment of the parents' view with our school mission and values.
- 3.4 The applicant from families in needs for whole day / long whole day edu-care service will be given due priority consideration.
- 3.5 The applicant with sibling(s) currently studying in our school will be given due priority consideration.

3.6 The applicant has sibling (s) of our school's graduated alumni.

- 3.7 Special social and care needs.
- 3.8 Residents in Fanling / Sheung Shui district.

As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place. Our school has the final interpretation and decision on the factors concerned.

4 Registration Arrangements

- 4.1 Successful applicants' parents should complete the registration procedures for their child from 4 to 6 January 2024 ("Centralized Registration Dates") by submitting the original of the "2024/25 Registration Certificate (RC)" to our school and paying the registration fee.
- 4.2 The registration fee for 2024/25 K class is HK\$ 1,570. For those admitted children, the registration fee will be deducted from the school fee in September 2024.
- 4.3 If parents cannot submit the "2024/25 RC" during registration, our school may not be able to complete registration for the child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period (September to November 2023).
- 4.4 If parents decide to change school after registration, please notify to us in writing. We will return the "2024/25 RC" but the registration fee will not be refunded. Upon obtaining the "2024/25 RC", our school will no longer keep the school place for the child.

5. Arrangement for admission application and supporting to non-Chinese Speaking Children

- 5.1 When interviewing NCS children, interpretation and/or translation service for applicants will be provided where necessary; or parents and children are allowed to be accompanied by a Chinese speaking relative / friend to facilitate communication.
- 5.2 Our School created an enriched language environment to facilitate their learning of the Chinese language. For further information, please visit our website.
